ON THE ABOVE DATE AND TIME, I PTL VELASQUEZ #144 WAS REQUESTED TO TAKE A REPORT OVER THE PHONE. WHEN SPEAKING TO THE CALLER, MICHAEL EDERY, HE STATED AN INCIDENT OCCURRED EARLIER LAST WEEK ON 11/27 AT AROUND 0920 HOURS. MICHAEL WAS HOME AT 6 RUNYAN WHEN HE HEARD A NOISE COMING FROM THE BACKYARD. WHEN CHECKING OUT THE BACK YARD HE CONFRONTED A WHITE MALE SUBJECT WITH A METAL ROD IN HIS HAND. BOTH PARTIES JUST STARED AT EACH OTHER AND THE UNKNOWN SUBJECT LEFT THE PROPERTY. - SEE INVEST FOR FURTHER.

THIS AGENCY RECEIVED AN ADDITIONAL NLETS MESSAGE FROM THE FBI NATIONAL THREAT OPERATIONS CENTER INFORMATION SHARING NETWORK ADVISING OF GENERAL CONCERNS LISTED BY THE COMPLAINANT (MICHAEL EDERY OF 6 RUNYAN AVENUE, DEAL). WITHIN THE SYNOPSIS OF THE NOTIFICATION EDERY APPEARS TO MAKING A SPECIFIC REFERENCE TO AN INCIDENT THAT OCCURRED ON 10-20-2021 WITHIN OUR JURISDICTION DURING WHICH TWO MASKED INDIVIDUALS ENTERED INTO THE BACKYARD OF THE RESIDENCE WHILE EDERY WAS PRESENT. INVESTIGATION DETERMINED THAT THE UNKNOWN INDIVIDUALS WERE ASSOCIATED WITH RECENT MOTOR VEHICLE THEFTS THAT WERE OCCURRING IN THE AREA AT THE TIME. EDERY ADDITIONALLY MADE MENTION OF HIS CELLULAR DEVICES BEING HACKED AS WELL AS OTHER UNUSUAL INCIDENTS THAT HAD PREVIOUSLY OCCURRED TO RELATIVES.

IMMEDIATELY UPON OBTAINING THE NLETS REPORT I ATTEMPTED TO CONTACT MICHAEL EDERY AT THE NUMBER PROVIDED ON THE REPORT, HOWEVER, THERE WAS NO ANSWER SO A MESSAGE WAS LEFT REQUESTING EDERY TO CONTACT THE DEAL POLICE DEPARTMENT. DUE TO OBTAINING NEGATIVE RESULTS VIA PHONE, I RESPONDED TO THE RESIDENCE IN ORDER TO ATTEMPT TO MAKE CONTACT WITH MICHAEL EDERY, HOWEVER, THE RESIDENCE WAS UNOCCUPIED AT THE TIME. OUT OF ADDED PRECAUTION, I CONDUCTED AN EXTERIOR CHECK OF THE RESIDENCE AND EVERYTHING APPEARED TO BE IN ORDER, NOTHING OBSERVED DAMAGED OR DISTURBED.

A COPY OF ALL RELATED INCIDENTS HAVE BEEN ATTACHED TO THE RESOURCES OF THE CAD FOR REFERENCE SHOULD THEY BE NEEDED IN THE FUTURE.
